I/We currently own, or are planning to purchase an electric golf cart. I/We understand that we must abide by the rules and regulations of the Association and Heritage of Hawk Ridge Golf Course. The guidelines are as follows:

1. Cart must be less than eight years old at the beginning of the season, and maintained in a manner consistent with golf course standards.
2. Only electric golf carts are permitted.
3. Management will take a photo of your golf cart for club records.
4. Golf cart must be a solid color.
5. Registration sticker must be displayed on the cart where it is clearly visible.
6. Any additional stickers or decals (other than Club Registration) are not permitted.
7. Carts must be housed inside owner's dwelling – outside storage is prohibited.
8. **Owners must provide Proof of Insurance, and continue to provide a current Certificate of Insurance with limits no less than \$30,000 to the Heritage of Hawk Ridge Community Association, with Heritage of Hawk Ridge, LLC and Walters Golf Management, Inc. listed as additional names insured.**
9. Lending or sharing of golf carts is strictly prohibited.
10. The annual registration fee of \$190.00 must be paid to Heritage of Hawk Ridge.
